He is a graduate of the National Trial Academy conducted by the ABA's Tort Trial and Insurance Practice Section and the American Board of Trial Advocates. He was Chair of the Federal Litigation Section of the Federal Bar Association from 2016 to 2018 and currently serves as its liaison to the FJC's Advisory Committee on the Federal Evidence Rules. Mr. McCarthy is a former FBA Circuit Vice President and past Chapter President of its S.D.N.Y. Chapter.

Mr. McCarthy received his Juris Doctor degree from the Fordham University School of Law in 1991, where he served as Managing Editor for the Fordham International Law Journal and as a member of the Moot Court Board. He is also currently an Adjunct Professor at Fordham University School of Law. His law school note on the use of international criminal jurisdiction to combat terrorism has been cited in more than two dozen scholarly works, including at least four treatises on international law, and in testimony to a bipartisan commission of the U.S. House of Representatives. He received his A.B. degree in Biology from Fordham University in 1988. During college he served as an International Trustee of Circle K International, the college level of Kiwanis International.

Mr. McCarthy is a past President of the Fordham College Alumni Association. He coached youth teams for Rockville Centre Soccer Club, Rockville Centre Basketball League, East Meadow Soccer Club and St. Agnes Cathedral Catholic Youth Organization (CYO).
