Mr. Thompson's practice includes environmental, commercial, and insurance-related litigation in state and federal court, as well as in state administrative court. He has represented and advised clients in connection with a range of environmental and commercial issues, including defending enforcement actions by the U.S. EPA and state environmental agencies, toxic tort litigation, Clean Water Act permitting and compliance, insurance coverage litigation, hazardous waste, Clean Air Act permitting and compliance, groundwater contamination, environmental cleanup and emergency response, and other environmental matters. Mr. Thompson serves as an adjunct professor at Emory University School of Law teaching a course in water law and environmental litigation.

Mr. Thompson is a Board Member for the Turner Environmental Law Clinic at the Emory School of Law, a member of the Metro Atlanta Chamber of Commerce, on the advisory board of Chattahoochee Riverkeeper, Inc., and is a Class of 2012 graduate of the Institute for Georgia Environmental Leadership.

From 1997 to 1998, Mr. Thompson served as a judicial clerk for the Honorable R. Lanier Anderson III, United States Court of Appeals for the Eleventh Circuit. Mr. Thompson received his B.A. degree, summa cum laude, in Politics from Wake Forest University in 1994, where he was a Carswell Scholar and a member of Phi Beta Kappa. In 1997, he received his J.D., with distinction, from Emory University School of Law, where he was elected to the Order of the Coif. While at Emory, he served as a Notes and Comments Editor of the Emory Law Journal.
