

Notice-of-Intent to Provide Offer for Consideration as a Company Self Build Proposal

GEORGIA POWER COMPANY

Entities desiring to offer the Company a solar photovoltaic generation resource that would be developed, constructed, and ultimately sold to the Company, can do so by contacting the Company self-build team. Contact can and should be made via the completion of this Notice-of-Intent (“NOI”) document and should be communicated to the Company (through the provided contact and address below) prior to the close of business January 13, 2014, to be given consideration. Consideration of an entity’s project(s) by the self-build team does not disqualify that entity from submitting bids for consideration into the RFP process. However, any project(s) submitted by the self-build team for consideration pursuant to the RFP will be disqualified from being offered as a bid into the RFP.

1. Facility type (Description: Fixed plate, Single axis or dual axis tracking):
2. Net of station service: Total facility capacity (Maximum alternating current (AC) rating)
3. Anticipate facility annual total plant energy (Net AC, a 8760 hour annual generation profile specific to the project is desired)

4. Facility annual degradation amount or rate (as applicable to maximum facility capacity and annual energy)
5. Location (County inside the state of Georgia). Map showing location of the facility (If provided or known), and statement of property control if attained. Latitude/longitude coordinates (if available)
6. Proposed panel/module vendor(s) to be used in the project
7. Proposed inverter vendor(s) to be used in the project
8. Proposed vendors for facility transformation equipment to be used in the project (includes any intermediate and final transformation equipment (GSU))
9. Final transformation voltage level (voltage level high side of the GSU)
10. Proposed facility block sizing (number of mega-watts aggregated per inverter)
11. Proposed facility configuration/layout (description on shape and orientation)
12. Prior project experience (provide number of and details of all projects completed of a size greater than or equal to 5MW)
13. Please provide your most recent safety metrics as it relates to your construction and development efforts and experience (Recordable Incident Rate or other)
