In the corporate/business law area, Anne has represented both family owned businesses and global enterprises, institutional and private lenders as well as borrowers and both investors and sweat equity partners. Anne is proficient in all types of secured and unsecured credit arrangements including factoring, trade finance, and letters of credit, syndicated loans, intercreditor agreements, and all manner of guaranties. She also has vast knowledge in the areas of mergers, acquisitions and dispositions, joint ventures, partnerships, and limited liability companies, employment agreements, covenants not to compete and confidentiality agreements, licensing and distributorship agreements and intellectual property issues, computer hardware and software contracts, master service agreements and statements of work, and all nature of routine matters for middle market companies.

In real estate, Anne's practice covers transactional real estate, including buying, selling and financing of real properties (mortgage and mezzanine loans and structured finance transactions for both lenders and borrowers), the use of special purpose and bankruptcy remote vehicles, hotel management, and brand/flag agreements, construction projects and loans and the representation of real estate investors in significant real properties. Anne has also negotiated leases big and small for offices, commercial businesses, restaurants, and related good guy guaranties.

In the bankruptcy/creditors rights area, Anne has acted as a trustee and has represented both debtors and creditors committees as well as individual secured and unsecured creditors in workouts, restructures, reorganizations, liquidations, and auction and other asset sales. Her work in this field also includes debtor in possession (DIP) loans for both borrower debtors and lenders and representing buyers and sellers of distressed debt.

Anne lectures and gives presentations regarding business entities, joint ventures, limited liability company, partnership investment and joint venture agreements, due diligence in lending transactions, third party loan documentation, and UCC and security arrangements and opinions. In addition, she has written articles on the use of special purpose entities and UCC Revised Article 9.

Going above and beyond the legal work, Anne is the Head of SGR's Women's Initiative in the New York office, a member of the Firm's Diversity & Inclusion committee, and supervisor and proponent of many of the New York office's pro bono activities including, most recently, The New York City Bar Association's pro bono COVID-19 project helping some of New York City's many small businesses.
