In January 2000, he organized "Same-Sex Marriage: A Panel Discussion," which featured constitutional law scholars from Vanderbilt and Yale Law Schools, where panelists aired ideas that ultimately became the basis of the United States Supreme Court's landmark ruling in Obergefell v. Hodges fifteen years later.

Mr. Delaney is a proud member of the Stonewall Bar Association of Atlanta. He is admitted to practice before Georgia state and federal courts, as well as the Second, Sixth, and Eleventh Circuits of the U.S. Court of Appeals.
