- Representing Mar-Jac Poultry, Inc., and its affiliates defending three class actions and over 80 opt-out direct actions alleging supply-reduction, market-manipulation, and bid-rigging conspiracies in the market for broiler chicken. *In re Broiler Chicken Antitrust Litigation*, Case No. 1:16-cv-8637 (N.D. Ill.). The plaintiffs in *Broiler Chicken* seek billions of dollars in damages for alleged violations of the Sherman Act, state and federal RICO, and related state laws. Victories to date include obtaining dismissal against three sovereign plaintiffs and settling all three class actions for a small fraction of damages alleged.

- In a series of related wage-fixing class actions, SGR and Mr. Youngblood successfully obtained dismissal before any discovery commenced. *Jien, et al. v. Perdue Farms, Inc., et al.*, Case No. 1:19-cv-2521-ELH (D. Md.).
- Successfully represented a nationwide construction materials manufacturer in a bid-rigging, fraud, and conspiracy investigation and prosecution conducted by the Department of Justice, Antitrust Division.
- Successfully represented a Series A funded startup medical device designer and manufacturer in connection with FDA and state regulatory approval proceedings.
