Mr. Monacell's public law experience includes structuring community improvement districts, enterprise and opportunity zones, tax allocation districts, public-private partnerships, intergovernmental contracts and management contracts for public facilities. He also represents government units, borrowers, underwriters, credit enhancers and corporate trustees in connection with tax-exempt securities offerings.

Mr. Monacell's practice includes assistance of for-profit and nonprofit enterprises locating or expanding projects with tax-exempt and taxable financing, tax abatement and other governmental incentives. He also has represented governmental and nonprofit hospitals in connection with their debt issuances.
