

# IRS Annual Cost-of-Living Adjustments – Employee Benefit Plan Limitations for 2021

# EFFECTIVE: JANUARY 1, 2021

The IRS has released the 2021 cost-of-living adjustments applicable to the dollar limitations on benefits and contributions of retirement plans and health and welfare benefit plans. We recommend plan sponsors update their systems and formulas to include the limits that have been adjusted.

<sup>(2)</sup> An employee with compensation greater than (i) \$130,000 in 2021 will be an HCE in 2022, (ii) \$130,000 in 2020 will be an HCE in 2021, (iii) \$125,000 in 2019 will be an HCE in 2020, and (iv) \$120,000 in 2018 will be an HCE in 2019.

<sup>(3)</sup> A "key employee" is any employee who, at any time during the plan year, is (i) an officer of the employer having annual compensation greater than \$185,000 (as indexed); (ii) a more-than-5% owner of the employer; or (iii) a more-than-1% owner of the employer having annual compensation from the employer of more than \$150,000.

<sup>(4)</sup> Employees pay an additional 0.9 percent on wages greater than \$200,000 for individuals (\$250,000 for married couples filing jointly).
