Liz frequently represents trustees and estate in pursuit of estate litigation claims across the country, including preferences, fraudulent transfers, and breach of fiduciary duty claims. Representative Experience

- Represented the Official Committee of Unsecured Creditors of Quantum Foods, LLC et al. as special litigation counsel in the U.S. Bankruptcy Court for the District of Delaware to pursue approximately 150 avoidance actions, which netted a gross recovery of over \$4 million for the benefit of the debtors' estates.
