In addition to her bankruptcy practice, she has represented plaintiffs and defendants in litigation arising under the Perishable Agricultural Commodities Act (PACA) in federal courts across the country and before the USDA. Ms. Janczak has also vetted PACA claims in chapter 11 cases as both special PACA counsel to the debtor and as creditors' committee counsel.
