He is therefore deeply familiar with deal structures and valuation methodologies, and adept at translating technical financial or accounting data into persuasive legal arguments. In short, he is especially effective for clients facing disputes where numbers tell the story, or where damages quantum is a key issue.

As a law student, David was awarded the Lincoln's Inn Lord Mansfield Scholarship, Hardwicke Entrance Award and Buchanan Prize, the University of Law Provost's Award for Excellence, and the City University Prize for Tort Law. He then served as Judicial Assistant to Sir Geoffrey Vos (Chancellor of the High Court) and completed pupillage at XXIV Old Buildings (a leading set of commercial chancery chambers). In both roles, he was exposed to cutting-edge issues in financial services litigation and the boundaries of legal professional privilege.
